My participation could also lead to loss or damage to personal property that may result from my participation in the Sturgeon Bay Open Bass Tournament.

In exchange for being permitted to participate in the Sturgeon Bay Open Bass Tournament, I hereby **RELEASE AND DISCHARGE** the tournament administrator, the SBOBT, the officers, directors, members and volunteers, and the tournament sponsors from the liability or injuries, damages or other loss sustained by me caused by negligence or strict liability of the Released Parties. I do not release the Released Parties from liability from willful or intentional conduct.

I expressly recognize that loss of property, injury or death could arise from (1) the fishing and boating activities contemplated by the tournament, (2) the fact that competition rules contemplate that participants will fish in boats belonging to **OTHER** participants in the contest, as well as their own boats, (3) the fact that the risks normally encountered in open water fishing from a boat may be enhanced by the existence of competition.
